





The Conditions of sale set out below ("the Conditions") are the terms and conditions agreed between **MNP** Auctioneers (Central) Sdn. Bhd. #### 1. Definitions

In these Conditions:

"The Seller" means any person or corporate who consigns any item to the Auctioneer for sale by auction;

"The Auctioneer" means **MNP** Auctioneers (Central) Sdn. Bhd. as agent and auctioneer appointed by the Seller to carry out the auction sales and to enter into agreement as agent on behalf of the Seller with the Buyer;
