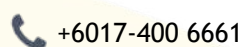
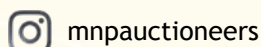

# The 4<sup>th</sup> Series of Malaysian Banknotes

## Distinctively Malaysia

The latest series of Malaysian banknotes draws its inspiration from elements which distinctively define the country's diverse culture, heritage and nature. Themed "Distinctively Malaysia", the fourth series of Malaysian banknotes features traditional expressions in the art and craft, natural wonders, flora and fauna, economy and tradition.

## Common Features

On the obverse, all banknote denominations in the new series retain the portrait of the first Seri Paduka Baginda Yang di-Pertuan Agong, Tunku Abdul Rahman ibni Tuanku Muhammad, the national flower *Rosa-sinensis* hibiscus known locally as the "Bunga Raya" and patterns of traditional woven fabric – the "songket".

The reverse of each banknote denomination features different elements of nature, tradition, culture, flora, fauna and the economy that are distinctively Malaysian.

# Description of Special Serial Numbers

Banknotes with special serial numbers are banknotes that have an intrinsic attraction and value to collectors and non-collectors. The actual reason why people are attracted to these numbers remains a mystery, but some believe that certain numbers have special meaning to certain individuals, like their birthdates, house numbers, phone numbers, car numbers, etc. On the other hand, some are attracted to these numbers because of “Feng Shui” or simply for good luck.

There are various types of serial numbers with meanings as per below:-

## Single Ladder

These are banknotes with ascending serial numbers having different prefix, e.g. EG1234567 whereas the “**Super Single Ladder**” means ascending numbers with same prefix, e.g. FF1234567. “**Reverse Single Ladder**” means descending numbers with different prefix, e.g. EG7654321 whilst those with the same prefix are called “**Super Reverse Single Ladder**”, e.g. FF7654321.

## Low Numbers

These are banknotes bearing the first ten digits e.g. AB 0000001 to AB 0000010 and auctioned as single note. If the prefix is the same, it will be considered as “**Super Low Numbers**” e.g. BB 0000001 to BB 0000010. The set of 10 refers to serial numbers bearing the first 10 digits auction in a set of 10 pieces, e.g. AB 0000001 to AB 0000010.

## Solid

These are banknotes bearing all same numbers with different prefix, e.g. AD 8888888 whereas “**Super Solid**” has the same numbers and prefix, e.g. CC 8888888.

## Ten Million

These are banknotes with eight digits serial numbers e.g. AA10000000 and fetches high value amongst collectors for its uniqueness.

## **Bidding Increments**

The bidding increments are standardized amounts to be used for bidding purpose when an item's bidding price increases from one price range to another. For example, if the starting bid is RM50, then the increment would be RM10, with the next bid raised to RM60, followed by RM70, RM80 and so on. When the same bid exceeds RM100, then the increment would be RM50, with the next bid raised to RM150, followed by RM200, RM250 and so on. At any point of time, the auctioneer may round up the starting bid as and when he or she thinks fit.

The "Wau Bulan", which is hand crafted from bamboo and paper, is also a popular decorative item that adorns the walls of Malaysian homes.

## RM 5 Polymer Banknote

### Wildlife

Featured on the new RM5 Polymer banknote is the Rhinoceros Hornbill (*Buceros rhinoceros*), one of the largest and most magnificent hornbill species in the world.

Found in low densities throughout various rainforests in the country, this beautiful, broad-winged and long-tailed forest bird plays an important role in the customs and traditional ceremonies in Sarawak which is known as 'Bumi Kenyalang' or 'Land of Hornbills'.

Hornbill is also seen as a symbol of strength and courage by the native communities of Sarawak.

**RM 10** Banknote**Flora**

Malaysia's lush tropical jungle, which is one of the world's oldest living rainforest, is home to a spectacular variety of flowering plants. Most iconic amongst them is the Rafflesia, the world's largest flower.

The Rafflesia Azlanii species featured on the new RM10 banknote is indigenous to Peninsular Malaysia and was first discovered in the Royal Belum Forest Reserve of the state of Perak in 2003.

To commemorate its discovery, this majestic flower was named after the late Sultan of Perak, Almarhum Sultan Azlan Muhibbuddin Shah ibni Almarhum Sultan Yusuff Izzuddin Shah Ghafarullahu-Lah.

## RM 20 Polymer Banknote

### Marine Life

As ambassadors of the rich and colourful marine life found in our tropical waters, two of the most well-known species of sea turtles endemic to Malaysian waters are on the new RM20 banknote – the Hawksbill Turtle (*Eretmochelys imbricata*) and Leatherback Turtle (*Dermochelys coriacea*).

The Hawksbill is easily identified by its curved beak and scaly shell while the Leatherback has a leathery skin and seven ridges on its shell.

These gentle turtles are a reminder that their existence rests in the delicate balance of human activity and marine life conservation.
